# A. RTP applicability to Performance Evaluations for Non-Tenure track Instructors (Dr. CariKeller)

Questions from the Chairs Council have been raised concerning evaluation of non-tenuretrack faculty. Do they use the same model as tenure track faculty? Some Colleges follow the model and some do not. What should be the expectations for Instructors and annual hires? Is there a different assignment or are they evaluated in all three areas: Teaching, Scholarship and Service? There are also questions about the timing. Evaluations in January/February must be complete before the March 1 deadline for non-renewal decisions. April Adams will be the new chair of the Chairs Council.

There is talk of merit raises for faculty in the coming year and these would be based on evaluations. There was proposal that a representative from each group meet to suggest one model for campus. This would include Deans, Chairs and Faculty Councils. There were questions about department guidelines and how they interact with the RTP policy. It is time to assess our process after two years of using it. The Chairs Council will meet again in August, Van Den Handel will meet with Adams about the issue.
