#### Regional summit in Pryor to address quality education needs

#### NORA works to strengthen Oklahoma's workforce and future

**WHAT**: A summit to discuss the importance of quality education and to reinforce the significance of public education as we work to strengthen Oklahoma's workforce.

WHEN: March 9, 2016, 10 a.m. - 1:30 p.m.

WHERE: MidAmerica Industrial Park Expo Center (Just east of Hwy 69, adjacent to MidAmerica Airport)

**PRYOR, Okla.**— Hundreds of the area's business, industry and education leaders from throughout northeast Oklahoma are meeting during the Third Annual Northeast Oklahoma Regional Alliance to discuss the importance of quality education and to reinforce the impact of public education on strengthening Oklahoma's workforce.

Featured speakers include Jonathan Catherman, senior consultant, Franklin Covey; Chuck Hoskin Jr., secretary of state, Cherokee Nation; and David Stewart, CEO, MidAmerica Industrial Park.

Participants will hear from business and workforce development representatives regarding the necessity of building a strong, educated workforce to retain current business and attract new business and industry.

Educators will focus on the importance of community involvement in education as they strive to keep Oklahoma competitive. Special emphasis will be given on the state of rural schools in Oklahoma and the effects impending cuts will have on the future of the children and the state. "State funding cuts over the past several years have created a critical problem in Oklahoma public education, and that affects the state's economy and well-being," said Jennifer Brittain, chair of the Pryor Area Chamber of Commerce. "Oklahoma public education is economics. We cannot afford to continue to cripple our state's education funding. Together we must work to save our schools."

A special discussion will be held regarding the Pryor School District's K-12 adoption of "The Leader in Me" program, based on the Stephen R. Covey's "7 Habits of Highly Effective People." Community leaders will relate how the program is not only impacting the schools, but also the entire city and its region.

The education summit is hosted by the Pryor Area Chamber of Commerce, MidAmerica Industrial Park and Pryor Public School District.
