MAP-Works Making Achievement Possible Scholarship Essay Contest

Official Rules

NO PURCHASE NECESSARY; A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

PLEASE CAREFULLY READ THE FOLLOWING OFFICIAL RULES. BY ENTERING THE MAP-WORKS MAKING ACHIEVEMENT POSSIBLE SCHOLARSHIP ESSAY CONTEST (THE "SCHOLARSHIP CONTEST") AND SIGNING THE ATTACHED AFFIDAVIT OF ELIGIBILITY AND RELEASE OF LIABILITY, YOU ACKNOWLEDGE AND AGREE, AMONG OTHER THINGS, THAT YOU HAVE REVIEWED, UNDERSTAND, AND AGREE TO BE BOUND BY THE OFFICIAL RULES. IF YOU DO NOT AGREE TO ABIDE BY THE OFFICIAL RULES, DO NOT ENTER THE SCHOLARSHIP CONTEST.

1. ELIGIBILITY: The Scholarship Contest is only open to individuals who are legal residents of the United States and who are at least eighteen (18) years of age as of the date of entry. In addition, entrants must: (i) attend a college or university that is a current MAP-Works partner; (ii) be enrolled in either the first or second-year at their college or university; and (iii) have participated in at least one MAP-Works survey during the 2011/2012 or 2012/2013 school years. THE SCHOLARSHIP CONTEST IS ONLY OPEN TO THOSE ENTRANTS FOR WHOM THEIR COLLEGE OR UNIVERSITY HAS AGREED TO PARTICIPATE IN THE SCHOLARSHIP CONTEST. IT IS THE SOLE RESPONSIBILITY OF THE POTENTIAL ENTRANT TO DETERMINE WHETHER HIS OR HER COLLEGE OR UNIVERSITY HAS AGREED TO PARTICIPATE IN THE SCHOLARSHIP CONTEST.

Employees and non-employee workers of EBI MAP-Works, LLC (the "Sponsor") and its affiliates, agents and agencies involved in the Scholarship Contest, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such ineligible person, are not eligible for entry into the Scholarship Contest. THE SCHOLARSHIP CONTEST IS VOID WHERE PROHIBITED.

- 2. ENTRY PERIOD: During the period beginning at 12:00 a.m. Central Standard Time ("CST"), January 28, 2013 and ending at 11:59 p.m. CST, April 13, 2013 (the "Entry Period"), you may enter the Scholarship Contest using the Method of Entry set forth in these Official Rules. The Sponsor's computer is the official time keeping device for the Scholarship Contest.
- 3. METHODS OF ENTRY: During the Entry Period, if your college or university has agreed to participate in the Scholarship Contest, you may enter the Scholarship Contest by completing an application which shall be made available to you by your college or university. As part of your application, all entrants must complete an essay of no fewer than 800 and no more than 1,600 words, which shall answer and/or address one (1) of the following three (3) essay questions:
 - i. How did MAP-Works affect your college experience?



- ii. What did you learn from the MAP-Works student report that caused a change in your college\behavior?
- iii. Was there a person that reached out to help you that had information from MAP-Works? How did that person affect you?

- 4. Award of Scholarship: Three winners (individually, a "Winner" or collectively, the "Winners") will each receive a scholarship in the amount of Fifteen Hundred & 00/100 Dollars (\$1,500.00) which shall be granted to each of the three Winners at the beginning of the 2013-2014 academic year. The funds from each scholarship will be transferred directly from the Sponsor to each Winner's college or university and shall be applied during the 2013-2014 academic year to assist each Winner with the payment of his or her tuition. The funds from each Winner's scholarship are non-transferable; therefore, if a Winner should fail to return to his or her college or university for the 2013-2014 academic year, such funds would be forfeited. Taxes associated with the acceptance of the scholarship are the sole responsibility of the Winners.
- 5. Judging: The Winners will be selected by a panel of judges (the "Judges"), which shall consist, in part or in whole, of members of the Sponsor. The Sponsor reserves the right, in its sole discretion, to vary the number and composition of Judges. The essays submitted by the entrants shall be judged blindly. Essays will be judged on both style and content. The Judges will look for writing that is clear, articulate and logically organized. Winning essays must demonstrate the significance MAP-Works has had on the entrant's college experience. The selection of the Winners, the Sponsor's interpretation of these Official Rules, and the Sponsor's decisions on all matters relating to this Scholarship Contest are final. The Sponsor reserves the right to substitute one Winner for another Winner.
- 6. WINNER NOTIFICATION: The Winner will be notified by electronic mail on a date following May 1, 2013.
- 7. ODDS OF WINNING: Odds of winning depend upon the number of eligible entries received.
- 8. GENERAL: The Sponsor reserves the right to cancel the Scholarship Contest without notice for any reason at its sole discretion. Acceptance of an offered prize by the Winner constitutes permission to use any of such person's name, likeness, and biographical information for advertising and publicity, without compensation, unless prohibited by law.
- 9. DISCLAIMERS: UNDER NO CIRCUMSTANCES, INCLUDING NEGLIGENCE, SHALL THE SPONSOR BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES THAT RESULT FROM THE ACT OF SUBMITTING AN ENTRY, OR INABILITY TO DO SO, INCLUDING DUE TO ANY AND ALL TECHNICAL MALFUNCTIONS FOR ANY REASON WHATSOEVER, OR
