Automated Telephone Request 1-800-908-9946. Request your Tax Return Transcript. Paper Request Form - Go to www.irs.gov. Enter 4506-T in search box. Print the form, fill out completely, and submit directly to the IRS (requested transcript will be mailed to the filing address of record with the IRS)
